

<b>Marriage</b>	Would oppose <b>HB444</b> <sup>ii</sup>  “There are ways to meet the needs of many couples and families addressed in HB444 through improving current beneficiary laws.” <sup>iii</sup>	Would have voted for <b>HB444</b> <sup>iv</sup>  “I believe that we must treat all people with respect and dignity, I would have voted in support.” <sup>v</sup>
